



COMMISSION TERMS · EFFECTIVE SEPTEMBER 15, 2026

Bespoke sound, clearly commissioned.

These terms keep every Solcaya commission private, focused and beautifully straightforward. By paying a deposit, the client confirms the selected tier, creative brief, quoted timeline and these terms.

01 · BOOKING

Payment secures the commission.

All prices are in U.S. dollars. A 50% non-refundable deposit is required to reserve the commission and begin work. The remaining balance is due before final, watermark-free files are released.

Any add-ons, rush fees or work outside the approved brief will be quoted separately and confirmed before that work begins.

02 · CREATIVE BRIEF

The timeline starts when the brief is complete.

Turnaround begins after Solcaya receives the deposit, completed taste consultation, required event details and all client-supplied music or voice assets. Delays in receiving materials or feedback pause the timeline.

03 · REVISIONS

Refinement stays true to the agreed direction.

- **Sol:** two revision rounds.
- **Caya:** revisions until the mix is right within the revision window.
- **Solcaya:** revision structure is set in the custom proposal.

Revision requests must be submitted within 14 calendar days of first delivery and grouped into clear, consolidated notes. A revision adjusts the existing brief; a new concept, substantially different track list, reordered event structure or added runtime is new scope and may require a separate quote.

Clean edits are available at no added cost when requested in the brief.



04 · DELIVERY

Final files arrive through a private link.

Standard delivery is seven days for Sol and five days for Caya. Solcaya commissions follow the dedicated timeline in the custom proposal. Delivery means the first complete mix is made available for review.

Final masters are delivered by private download link in MP3 and WAV. Stems are included with Caya and only with Sol or Solcaya when stated in the proposal.

Rush delivery faster than the standard timeline may be available for an additional fee. Availability and the rush fee must be confirmed before booking; a requested date is not reserved until confirmed.

05 · CANCELLATION

Refunds depend on whether work has begun.

- **Before work begins:** payments are refunded, less non-refundable payment-processing fees.
- **After work begins:** the deposit is retained. Any amount paid above the deposit for work not yet completed will be refunded.
- **After final delivery:** sales are final. Concerns are handled through the applicable revision policy rather than a refund.

06 · USE & LICENSING

The mix is licensed for private use.

Unless a written proposal states otherwise, each mix is created for the client's private, personal use. Solcaya does not sell, transfer or grant ownership of third-party recordings, compositions, samples or other protected material contained in a mix.

The client is responsible for permissions or licenses required for public performance, broadcast, commercial release, paid advertising, streaming, resale or distribution. For an event, the client and venue are responsible for any applicable public-performance obligations, including those administered by ASCAP, BMI, SESAC or other rights organizations.

07 · DISCRETION

Privacy is part of the commission.

Inquiries, consultations and deliveries are handled privately. Solcaya may describe completed work only as an anonymous case study, without identifying the client, guests, planner, venue or event unless written permission is given.

Solcaya-tier clients may request a mutual non-disclosure agreement before confidential details are shared. White-label delivery is available for planners, allowing files and communications to be presented under the planner's direction where agreed in writing.

Simple changes, agreed in writing.

If the client and Solcaya agree to change the scope, price, timeline or delivery format, the written proposal or confirmation controls for that commission. If one part of these terms cannot be enforced, the remaining terms continue to apply.
